Sustain the deviated fixed-route and curb-to-curb paratransit services for the general public, disabled, low income, elders and persons with special needs from various community subdivisions throughout the Makah Reservation.

Need*:

The project need is to sustain the only public transportation to the community on the Makah Reservation including the elderly, handicapped and low-income populations. The Transit schedule and route is based on the ability for the community to access such essential services such as Health Clinic, Senior Meal Program, Social Services, employment and governmental offices. In addition the schedule and route is designed for community to connect with the Clallam Transit service so they may access off-reservation needs.

Special Needs Transportation:

By having reliable buses with wheel chair accessories, we are able to meet the needs of the elderly and handicapped population so they may access services at the various subdivisions in the community. Tribal government services are not all available in one location and the primary health clinic is approximately 2.5 miles away from the Wellness Center which provides mental health, chemical dependency counseling, acupuncture and massage therapy. The low-income and/or individuals with drug addictions often must see the medical provider and then go to the Wellness Center for addiction services and the Transit is key in ensuring people can easily travel between destinations.

This allows individuals to access services off the reservation i.e., medical appointments, pick up prescriptions, grocery shopping, education services and this will allow individuals with a continuum of health care, and to meet the family needs.
